unn was pursuing a degree in finance when his brother, finishing up law school at the time, proposed a career in law.

"He suggested I look into it, because he knew I'd been arguing with him for years and it would be a natural fit," Dunn quipped. "The element most interesting to me is the storytelling aspect of law — being able to tell the client's story in a way that is persuasive and intelligent."

Add to that an appreciation for the adversarial process and a competitive spirit, and Dunn had found his calling.

Dunn serves as the lead partner in Mintz Levin's West Coast Bankruptcy and Restructuring practice, focusing primarily on corporate reorganization. He has represented Chapter 11 debtors, secured and unsecured creditors, bondholders and indenture trustees, Chapter 7 and Chapter 11 trustees, and purchasers of distressed assets.

Dunn played a central role in *Tatung Co. vs. Hsu*, a complex, multinational dispute in which he helped recover \$20 million for his client, Taiwanese corporation Tatung Co.

"We litigated it hard for three years, and on the eve of the trial, we ended up obtaining a very favorable settlement for our client," he said. "It was a great learning experience and a testament to our perseverance, and it paid off."
