



## Health Care Weekly Preview

*Week of February 12<sup>th</sup>*

We closed last week with a budget deal that addressed nearly every health care stakeholder issue. With 2017 finally over, we begin 2018 with the next budget. This week the Administration will release its FY 2019 budget and will spend the next couple weeks defending and promoting it. We wait to see how the budget will be received by the Republican-controlled Congress.

Typically, the Administration's annual budget exercise is a way to offer priorities and elevate issues that may not be palatable legislatively. However, it's being reported that the President's budget will aim to reduce the deficit by \$3 trillion the next 10 years, rather than eliminate the deficit, a typical conservative guiding principle. After the massive spending increase in the budget agreement and a formal budget proposal that doesn't come into balance, expect conservatives to be overt in their criticism.

On the regulatory side, a proposed rule around short-term limited duration insurance (STLDI) plans cleared the White House Office of Management and Budget (OMB) last week. STLDI's are exempt from several ACA requirements, and are opposed by a number of health care stakeholders who argue these plans are not comprehensive and would undermine the individual market. With market stabilization still looming as a potential 2018 issue, will release of the STLDI regulation drive Congress to reach an agreement or drive Congress further from consensus?

### **340B AND DRUG PRICING**
